**1. E-WASTE DISPOSAL & RATES:**


- (i) Nature of E-Waste : CPUs, Monitors, Printers, Scanners, Electronic Displays, Keyboards, Mouse, Hard disks, Power Supply Function generators, Trainer kits 8085, flip\_flop Trainer kits, shouldering kits, etc.,
- (ii) Rates: Detail as per Annexure-I enclosed  
The Vendor will pay to **PBSCAS** the agreed rate Including All Taxes of e-waste collected from **PBSCAS**. The payment will be made by Demand draft or cheque issued NEFT/RTGS by Vendor in favor of **Principal, P B S College** on same day of lifting E-Waste from **PBSCAS** Campus.


**2. TERMS & TERMINATION**

- (i) This Agreement will be effective from 6th December, 2019 and shall be valid for a period of two year i.e. 06.12.2019 to 05.12.2021 and may be extended further with mutual consent of the parties.
- (ii) This Agreement may be terminated by either parties by giving 30 days prior notice

**3. OBLIGATIONS OF VENDOR**

- (i) Vendor will issue to **PBSCAS** a certificate indicating the date, quantity and type of E-Waste safely disposed by them.
- (ii) Vendor will be required to complete with all Environment, Health & Safety rules and regulations prevalent statutory laws and regulations (State & Central) pertaining to pollution control and the environment with respect to E-Waste disposal, transportation and recycling. In case of any violation, **Vendor** will be responsible and will indemnify and hold **PBSCAS** harmless against any claims / legal matters arising out of relating to e-waste disposal of **PBSCAS**.
- (iii) All statutory documents in accordance with MOEF/CPCB guidelines under E-Waste (Management and handling) Rules 2016 shall be provided by **Vendor** at the time of taking delivery of the material from.
- (iv) The E-Waste detailed in Annexure-I shall be provided properly so as to prevent any damage / spillage of this material during transit to **Vendor's** factory at F-394, Phase-I, Industrial Area, M.G Road, Hapur, Uttar Pradesh-245101.
- (v) All Transportation costs shall be borne by **Vendor** however **PBSCAS** shall provide fork lift for loading of E-Waste (at their own cost).
